


Business Description

Banco Bradesco is Brazil's second-largest private bank, with about 15% of deposits, and the largest insurance provider in Brazil, with roughly 20%-25% market share. The bank is majority controlled by the Bradesco foundation—a private nonprofit institution focused on education. Banking provides roughly 70% of profits, while the insurance segment contributes the remaining 30%. The bank is also a major asset manager with high-single-digit market share. In 2016, Bradesco acquired the Brazilian operations of HSBC.

Valuation ^Qas of 17 May 2024

Morningstar affirms a 3-star quantitative rating for Bank Bradesco. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 2.42, a discount of 16.65% to its Quantitative Fair Value estimate of 2.90. This discount has ranged between 34.16% and 7.76% over the past year. The stock's price to fair value ratio is at the 61st percentile in our global equity coverage universe for this methodology and at the 48th percentile relative to its peers in the financial services sector.

Bank Bradesco furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 02/29/2024, before which it was 4-star. Similarly, the firm's uncertainty rating changed from High to Very High after 02/01/2024.

We examine the financials and market statistics for Bank Bradesco to determine these ratings. Its earnings yield is 8.63% and its trailing 12-month maximum drawdown is 26.86%. These fall at the 82nd and 46th percentiles in the equity universe and at the 62nd and 68th in the financial services sector, respectively.

Economic Moat ^Q as of 17 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.28 sits at the 28th percentile in the financial services sector. This is a decrease from 0.53, the maximum of its moat scores over the past year.

The quantitative financial health rating for Bank Bradesco is Strong. Its financial health score, termed Distance to Default, sits at the 94th percentile in the universe and 65th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Bank Bradesco is 116.19%, and its enterprise value-to-market value ratio is 0.00. They sit at the 78th and 5th percentile in the global equity universe, respectively.

Fundamentals as of 17 May 2024

Bank Bradesco maintains earnings per share of 1.16. The shares offer a dividend yield of 4.52%. These values are calculated over a trailing 12-month period.

As of last market close, Bank Bradesco has a priceto-earnings ratio of 11.58, falling below the 49th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 9.26 and 14.79 over the past year.






Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\overrightarrow{\text{High}}-\text{the}$ interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

Other Definitions

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
