



### **Business Description**

Petrobras is a Brazil-based integrated energy company controlled by the Brazilian government. The company focuses on exploration and production of oil and gas in Brazilian offshore fields. Production in 2023 was 2.8 million barrels of oil equivalent a day (80% oil production), and reserves stood at 10.9 billion boe (85% oil). At end-2023, Petrobras operated 10 refineries in Brazil with capacity of 1.8 million barrels a day and distributes refined products and natural gas throughout Brazil.

### Valuation as of 17 May 2024

Morningstar affirms a 3-star quantitative rating for Petrobras Brasileiro. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 7.33, a discount of 4.83% to its Quantitative Fair Value estimate of 7.71. The stock has been trading between a 24.1% discount and 12.62% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 83rd percentile in our global equity coverage universe for this methodology and at the 84th percentile relative to its peers in the energy sector.

Petrobras Brasileiro furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating dates to after 10/02/2023, before which it was 2-star. Similarly, the firm's uncertainty rating changed from Very High to High after 02/28/2024.

We examine the financials and market statistics for Petrobras Brasileiro to determine these ratings. Its earnings yield is 22.59% and its trailing 12-month average volume (primary share) is 19,471,323 shares. These fall at the 95th percentile in the equity universe and at the 92nd and 94th percentiles in the energy sector, respectively.

### Economic Moat <sup>Q</sup> as of 17 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.09 sits at the 17th percentile in the energy sector. This is a decrease from 0.6, the maximum of its moat scores over the past year.

The quantitative financial health rating for Petrobras Brasileiro is Moderate. Its financial health score, termed Distance to Default, sits at the 34th percentile in the universe and 37th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Petrobras Brasileiro is 83.00%, and its annualized trailing 12-month volatility is 28.03%. They sit at the 64th and 41st percentile in the global equity universe, respectively.

### Fundamentals as of 17 May 2024

The earnings per share for Petrobras Brasileiro is 1.72. The company earns a return on invested capital of 18.14%, falling at the 86th percentile in the energy sector. The firm maintains a dividend yield of 12.25%. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Petrobras Brasileiro holds a price-to-earnings ratio of 4.61, a figure greater than 15% of its sector peers. The company's price-to-free cash flow ratio is 3.47, greater than 12% of its sector peers. These values are calculated using the stock's price at last market close.



## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

- iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
